The Royal Swedish Legation presents its compliments to the Ministry of Foreign Affairs and has the honour, on the instructions of the Swedish Government, formally to denounce the Declaration of 24 December 1927² between Sweden and the Netherlands regarding the mutual recognition of Dutch and Swedish tonnage certificates and the special Agreement and Protocol forming part of that Declaration.

These agreements have in fact ceased to serve any useful purpose since 30 December 1954, the date of the entry into force of the Convention for a uniform system of tonnage measurements for ships, signed at Oslo on 10 June 1947.³

The Legation has the honour to state further that in order to avoid any misunderstanding concerning the applicability of the above-mentioned Declaration and the special Agreement and Protocol forming part thereof, the Swedish Government renounces all rights deriving therefrom as from 30 December 1954.
