AGREEMENT¹ BETWEEN THE GOVERNMENT OF DEN-MARK AND THE GOVERNMENT OF THE REPUBLIC OF UGANDA ON THE ESTABLISHMENT OF A DAIRY SCHOOL AT ENTERBE

The Government of Denmark and the Government of the Republic of Uganda, desirous of further strengthening the friendly relations between their peoples, and recognising their mutual interest in the economic and technical developments of their countries, have agreed, in accordance with the Agreement on Technical Cooperation between the two Governments, concluded at Kampala on the 3rd day of July 1968, to collaborate in establishing a Dairy School at the Veterinary Training Institute, Entebbe.

Article I

The aim of this Agreement is to further the expansion of the dairy industry in Uganda, and to promote education in dairy and related subjects in order to improve and increase animal production, especially milk production.

Article II

In order to enable the holding of courses in dairy education at the farmer, operator, manager, diploma and possibly university level, the Danish Government undertakes, within the limits of funds allocated for this purpose, to provide the following additional facilities at the Veterinary Training Institute at Entebbe:

- (a) a building with equipment for a pilot/teaching milk plant with a capacity for processing 2,000 litres of milk per day;
- (b) laboratory, classroom and office facilities including equipment, furniture, and fittings:
- (c) a trainees' residence providing housing for 40 students;
- (d) a pilot/teaching dairy farm;
- (e) two 3-bedroom and two 2-bedroom staff houses;
- (f) equipment and vehicles necessary for the operation of the courses.

Within the limits of funds allocated for this purpose, the Danish Government will also provide the designs and layouts necessary for the construction, and the transport of equipment from Denmark to the site. Furthermore, provision will be made for paying all costs connected with making available through FAO a Danish milk plant manager and a Danish farm manager for the Dairy School for a period of three years.

Article III

- 1. The Government of the Republic of Uganda, through the Ministry of Animal Industry, Game and Fisheries, will assume responsibility for carrying out the objectives of this Agreement in conjunction with the Danish Government and FAO.
- 2. The Government of the Republic of Uganda will sponsor and develop a diploma level course in dairy husbandry and technology which shall be centered on the facilities to be provided at the Veterinary Training Institute at Entebbe. These courses will occupy three years training, that is, two years as veterenary assistants and one year on dairy husbandry and technology.
- 3. The Government of the Republic of Uganda undertakes also to encourage training in dairying in Uganda for suitable candidates from other English-speaking countries in Africa. To these ends the Government undertakes to conclude an agreement with the United Nations Food and Agricultural Organisation (FAO) for the continuation of dairy training and demonstration courses for Uganda and other English-speaking countries in Africa to be held at the facilities listed in Article II. This Agreement shall be based upon the Agreement, concluded on 24 May, 1963,¹ between the Government of the Republic of Uganda and the United Nations Technical Assistance Board on behalf of the participating organisations and the Letter of Agreement, dated 30 July 1965, between the Government of the Republic of Uganda and FAO regarding the FAO Dairy Training and Demonstration Courses for English-speaking Countries in Africa.
- 4. In addition, the Government of the Republic of Uganda will hold short courses for the training of farmers, milk plant operators, dairy extension workers and others concerned with dairying in Uganda.
- 5. The Government of the Republic of Uganda will make available counterparts and other local personnel required for the satisfactory conduct of the courses.

- 6. The Government of the Republic of Uganda will provide such materials, supplies, equipment and financing not covered by article II. In particular, the said Government will provide the following non-recurring items:
 - (a) land for the sites of the milk plant' hostel, laboratories, classroom, offices' dairy farm and staff houses;
 - (b) the preparation of work surfaces for the buildings, such as roads, drainage, leveling fences, gates, etc.;
 - (c) labour, materials and supervision for the installation of services including water, sewage, electric power and lighting, and telephone;
 - (d) any fittings, furniture and equipment not provided by Denmark for the buildings;
 - (e) working capital for the milk plant and the farm;
 - (f) hard furniture for staff houses and hostel.
- 7. The Government of the Republic of Uganda shall bear the following integral parts of the basic operational costs of the milk plant, hostel and dairy farm:
 - (a) running of the completed project, including remuneration of local staff;
 - (b) maintenance and repair costs of the buildings after completion;
 - (c) sufficient reserve for depreciation and replacement of equipment, vehicles, building and other capital assets;
 - (d) funds for normal expansion.
- 8. The Government of the Republic of Uganda will through the appropriate agencies undertake the transport from Mombasa to the site in Entebbe as well as the necessary customs clearances etc. of all equipment and materials. Costs in connection therewith will be reimbursed by Denmark but the Uganda Government will ensure that all such items are free of duty.
- 9. The Government of the Republic of Uganda will ensure that the expenses of the farm and of the milk plant can be covered by income from sales so that a separate account is kept for each of the two units.
- 10. The Government of the Republic of Uganda, through the appropriate health authorities, undertakes to develop and enforce the essential sanitary codes required to safeguard the handling, processing and distribution of milk products in the area.

- 11. The Government of the Republic of Uganda will undertake to provide teaching posts for locally recruited, properly trained staff, upon withdrawal of the expatriate personnel and will provide for eventual assumption of the responsibility for the running of the milk plant and dairy farm, and the dairy training programmes.
- 12. The Government of the Republic of Uganda will keep the Danish Government and FAO informed of the progress of the project. Brief reports will be submitted each quarter on work completed, equipment received and issued stocks in hand, etc. In addition, a report will be prepared each year to provide an overall assessment of the results obtained.
- 13. The Government of the Republic of Uganda shall assume full responsibility in respect of any claim against the Danish Government, its employees and agents, in connection with any assistance which has been provided. In the event that the Government of the Republic of Uganda shall make any payment under the terms of this clause, the said Government shall be entitled to exercise all the rights, claims and interests which Denmark could have exercised against third parties. This clause shall not apply with respect to any claim against Denmark for injuries incurred by Danish staff members.
- 14. The legal position of Danish staff members shall be dealt with according to Article 6 of the above-mentioned Agreement on Technical Cooperation between the two Governments dated 3 July, 1968.

This Agreement will come into effect upon signature by the parties. It will be valid for three years and may be terminated by either of the contracting parties by six months' written notice.

IN WITNESS HEREOF the undersigned, being duly authorised, have signed his Agreement.
