EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹
BETWEEN THE GOVERNMENT OF DENMARK AND THE
GOVERNMENT OF BANGLADESH CONCERNING A DANISH
GOVERNMENT GRANT OF PIG IRON

I

December 17, 1976

Sir,

With reference to previous discussions and correspondence regarding a grant of pig iron by the Government of Denmark to the Government of Bangladesh, I have the honour to propose that the following provisions shall govern the transfer of the grant:

I. Subject to the following provisions and such other provisions as may be agreed upon between the parties, the Government of Denmark shall within the sum of Danish kroner 5,800,000,- (five million eight hundred thousand) make available to the Government of Bangladesh a grant of up to 8,000 tonnes of pig iron.

II. The specifications of the consignment are mentioned in the attached enclosure.

III. The Government of Denmark acting through the Danish International Development Agency (DANIDA) will purchase the pig iron and deliver the same c.i.f. at Chittagong port. The consignment will be addressed to:

Bangladesh Steel Mills Corporation
Dacca.

As soon as possible after shipment of the goods DANIDA will forward sets of non-negotiable shipping documents to:

Chittagong Steel Mills Ltd.
Chittagong.

IV. The Government of Bangladesh will assure prompt unloading and will be responsible for all expenses and arrangements in connection with the clearance of the goods and their transport inside Bangladesh.

V. One year after the delivery the Government of Bangladesh will submit a report to DANIDA regarding the utilization of the Danish grant.

If the foregoing provisions are acceptable to the Government of Bangladesh I have the honour to suggest that this letter and your reply to it constitute an agreement between our two Governments.
