EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹
BETWEEN FRANCE AND MAURITIUS ON THE MAURITIAN
CONTRIBUTION TOWARDS THE COST OF FRENCH TECH-
NICAL ASSISTANCE

Paris, 14 September 1979

Sir,

Pursuant to the provisions of article XII of the Franco-Mauritian Agreement for Cultural and Technical Co-operation of 22 June 1970² and note verbale No. 66/71-518 717/10 of 20 October 1971 from the Ministry for Foreign Affairs, Tourism and Emigration, the contribution of the Government of Mauritius towards the cost of French technical assistance was established at the rate of 500 Mauritius rupees per month per official. This contribution has remained unchanged since 1971. In order to take into account the considerable increase in the cost of technical assistance provided since 1971, I have the honour to propose to you that the rate be increased to Mau RS 650 monthly beginning on 1 October 1979.

This contribution shall be paid for each official seconded to the Government of Mauritius for the entire period of secondment, including the regulation period of leave following completion of the tour of duty.

A statement of claims, prepared on the basis of the number of personnel on duty or on regulation leave as at the first of each month, shall be produced monthly by the Government of the French Republic.

The rate of the contribution shall be revised, as appropriate, at the request of either Party, so as to take into account changes in the cost of technical assistance.

I should be grateful if you would confirm that you agree to the above provisions.
