AGREEMENT¹ BETWEEN THE KINGDOM OF SWEDEN AND THE REPUBLIC OF TAJIKISTAN CONCERNING THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

The Kingdom of Sweden and the Republic of Tajikistan, desiring to strengthen and develop relations between Sweden and Tajikistan in accordance with the purposes and principles of the Charter of the United Nations and the principles of the Final Act of the Conference on Security and Cooperation in Europe,²

Have agreed as follows:

Article 1

Sweden and Tajikistan shall, on the day this Agreement enters into force, establish diplomatic relations with each other and shall exchange diplomatic representatives as soon as possible.

Article 2

The Parties to this Agreement agree that the provisions of the Vienna Convention on Diplomatic Relations of 18 April³ 1961 shall apply to diplomatic relations between them.

Article 3

The Parties to this Agreement agree that the provisions of the Vienna Convention on Consular Relations of 24 April 1963⁴ shall apply to consular relations between them.

Article 4

This Agreement shall enter into force at the time of its signature.
